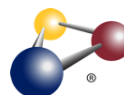

## 4. First-aid measures

### Product AS SOLD and AT USE DILUTION

<b>Eye contact</b>	: Rinse with plenty of running water. Seek medical advice if symptoms occur.

<b>Extinguishing media</b>	: Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

<b>Product AS SOLD and AT USE DILUTION</b>	
<b>Personal precautions</b>	: For small spills ensure suitable equipment and PPE is used. Dispose of waste in accordance with local rules. For large spills the following PPE is recommended to reduce risk: safety glasses, chemical resistant shoes & gloves, long sleeves / trousers. Remove non-essential personnel from the area. Ensure that any alkalis or other products of incompatible classes near the spill are removed.
<b>Environmental precautions</b>	: Contain large spills/releases using appropriate bunding or capping. Prevent entry into drainage systems, sewers and waterways.
<b>Methods for cleaning up</b>	: Spills may be slippery. Small spills use mop and bucket, for larger spills contain with absorbent material, collect and dispose.

<b>Handling</b>	: Use clean dispensing equipment, Use appropriate PPE, Always add product to water when diluting.
<b>Storage</b>	: Store in a cool, dry, well ventilated place. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store in original containers whenever possible. Do not store in metal containers without prior approval. Check container compatibility before transfer. Keep containers closed when not in use - check regularly for leaks. Ensure good housekeeping in storage area.

<b>Product AS SOLD and AT USE DILUTION</b>	
<b>Occupational exposure limits</b>	: No information available on the product itself. Values for specific hazardous ingredients are shown in section 3.
<b>Engineering measures</b>	: Use sensible work practices that reduce operator exposure to the product. Ensure that adequate ventilation is provided, and air is moving constantly in the area of use while drum is open. Keep containers closed when not in use.
